Social Sector Size Criteria Sometimes referred to as 'Bedroom Tax' this Welfare Change comes into effect 20 February 2017

**Housing
Executive**

Who will be affected?

It will affect social housing (Housing Executive and housing association) tenants considered to be 'under-occupying' their homes. It does not apply to privately rented properties.

What is happening to households affected?

If a household is considered to be 'under-occupying', the rent used to calculate Housing Benefit will reduce by:

- 14% if under-occupied by 1 bedroom, or
- 25% if under-occupied by 2 or more bedrooms

Welfare Supplementary Payment

The Northern Ireland Executive committed to alleviating Social Sector Size Criteria. If a household's Housing Benefit goes down because of the changes they will receive a Welfare Supplementary Payment. These are in place until 31 March 2020.

Those affected do not have to apply for Welfare Supplementary Payments. The Department for Communities and the Housing Executive will work together to automatically calculate the amount to be paid which will be credited to the claimant or social landlord receiving the Housing Benefit payments.

What does the size criteria allow?

The Social Sector Size Criteria now allows one bedroom each for:

- every adult couple
- anyone else aged 16 or over
- any two children of the same sex aged under 16
- any two children aged under 10
- any other child (other than a foster child or child whose main home is elsewhere)
- children who can't share because of a disability or medical condition
- a carer (or team of carers) providing overnight care

Those living in a Housing Executive or housing association home aged 16 years or over but below State Pension age receiving Housing Benefit will be affected. Pensioners are not affected.

How will the household know if they've been affected?

An early notification letter is being sent to all Housing Executive and housing association households likely to be affected by Social Sector Size Criteria. This phased posting started 17 January 2017 and will take 2-3 weeks for all letters to be issued. It is due to be completed by 3 February 2017.

The mailing will contain a Household Details Form containing the information we have on record for the household. Householders will be asked to check this information and if it is correct there is nothing to do. If the information is incorrect you should make the amendments on the form and return it to the Housing Executive in the prepaid envelope provided.

Who is not affected by the changes?

You will not be affected by Social Sector Size Criteria if:

- you or your partner have reached State Pension age
- you live in exempt supported accommodation
- you live in a houseboat, caravans or mobile home
- you live in a shared co-ownership scheme
- you live in temporary accommodation

Are any households allowed an extra bedroom?

Your household may be allowed an extra bedroom if you are:

- an approved foster carer who has a child placed with you
- an approved foster carer who is between placements but only for up to 52 weeks from the end of the last placement
- a newly approved foster carer for up to 52 weeks from the date of approval if no child is placed with you during that time
- If a student or member of the armed forces has a bedroom in your home but they're away, their bedroom won't count as unoccupied.

Over 150 attended the 5 Public Workshops with representation coming from HCN Members, Housing Executive Tenants, Residents, Community Partnerships and various Stakeholders including; 3rd Sector Organisations, Council Officers as well as employees from the Youth, Health and Education Sectors.



Consultees were invited to give their feedback under 3 key headings:

- 'What worked well in the outgoing Strategy?'
- 'What could be improved?'
- 'Where Next for the new Community Involvement Strategy?'

Minister Givan announces first tenancies under the Rent to Own scheme

Communities Minister Paul Givan has welcomed news that 22 households are now on the path to home-ownership through the new innovative Rent to Own scheme.

Five households have moved in to their new homes and another 17 households have been accepted onto the scheme and will be moving into their new homes over the next few months.

The pilot scheme, which has been made possible by a £12.5 million investment by the Department for Communities, is targeted at assisting lower income households onto the property ladder. It does this by providing customers with the opportunity to rent a new home of their choice for up to three years and, at the end of the rental period, receive a rent rebate of 25% towards a mortgage deposit to purchase the property.

Minister Givan said: *"I am delighted that 22 individuals and families now have a new home, or will have a new home in the near future, as a result of the Rent to Own pilot. Rent to Own represents a new way of thinking and shows how my Department is supporting the aspirations of people who want to get on to the property ladder."*

Increasing housing supply is a key priority for my Department. My officials continue to look for new ways of meeting housing need across all tenures.

The success of the Rent to Own scheme pilot so far offers key learning opportunities for how we design and deliver future initiatives."

The scheme is being exclusively delivered via OwnCo Homes, a subsidiary of the Northern Ireland Co-Ownership Housing Association, and aims to deliver 90 affordable new homes across NI over the next two years.

Mark Graham, Chief Executive of Co-Ownership Housing said: *"Rent to Own offers tenants a better option than simply renting, with no prospect of a return. It starts with a commitment to a three year payment plan with a down payment of £2,500 and an inbuilt 25% rebate on rent paid. Together they build up a lump sum to be used towards purchasing the property. We really are thinking differently about renting."*

The product is available for homes in Northern Ireland and will typically provide new build turnkey type homes in the starter home price bracket of around £100,000 - £150,000, excluding one-bedroom properties and apartments.

Consultation on the Homelessness Strategy Ends 8th February

On Wednesday 30th November 2016, the Board of the Housing Executive approved the draft Homelessness Strategy 2017-22 – “Ending Homelessness Together”. The Housing Executive is undertaking an external consultation exercise, to seek feedback on the strategic direction the organisation has set out in the document.

The Strategy sets out key objectives and associated actions aimed at preventing homelessness where possible and finding long term sustainable housing and support solutions for those households faced with homelessness. The Strategy supports a multi-agency approach to tackling homelessness and recognises the importance of local service delivery.

Views on the draft Homelessness Strategy proposals are welcome from as wide a constituency as possible including interested parties from all backgrounds, community representatives as well as statutory, private and voluntary bodies.

Health Minister to continue VCS Core Grant Fund



The Health Minister, Michelle O'Neill has confirmed that she will continue the core grant fund to the voluntary and community sector.

Many voluntary and community sector organisations work closely with users of health and social care services and can advocate on their behalf. This has the potential to help us shape health and social care services in the future, to make them better and more responsive to the needs of the people of the north who they are intended to serve.”

Work had been ongoing that would have seen the core grant scheme phased out alongside the introduction of a new innovation scheme.

A new core grant scheme with an innovative component will be designed in due course, it will be open to all VCS groups. In the interim the Minister will not be progressing a planned 25% reduction in the core grant scheme.

In making this decision the Minister has stated her concern that the removal of the scheme would result in the weakening of the strong advocacy voice of the sector.

Making a statement today the Minister said, "I want to support voluntary and community sector organisations that can assist with the delivery of my vision for health and social care in the north, with an emphasis on transformation.


I have decided to do that by way of providing organisations with funding to support their core functions.

Welcoming the Minister's decision NICVA Chief Executive Seamus McAleavey said, “*The Minister* and her officials have been in discussion with us for some months now and we are delighted she has made this decision. NICVA expects that the new funding scheme will be in place for April 2018 and in the meantime she will maintain the existing scheme with no cuts next year.

Voluntary and community organisations have a big part to play in the Minister's Transformation agenda and NICVA supports the vision that she has set out to transform health in Northern Ireland.

We recognise the challenge is huge and requires the united support of a Northern Ireland Executive if it's to be achieved. If there is an election then the task falls to the incoming Executive and possibly a new Minister but the challenge remains the same and will need unity of purpose”.

Preparing For Severe Weather

Are you prepared for severe weather?

Here you'll find some useful tips on how to prepare in your home, on the move and in your community.

Where	How to prepare
In your Home	<p>Keep an emergency kit (include items like battery/windup radio and torch, spare batteries, candles and matches, a phone that doesn't require mains electric to work, list of useful numbers list of medications that you are taking, copies of household insurance policies.</p> <p>Make sure your heating is safe and that your house is properly ventilated.</p> <p>Know how to turn off your electricity supply at the mains.</p> <p>Know where your stop valve is and how to turn off your water.</p> <p>Follow NI Water's advice on protecting your pipes: visit www.niwater.com for details.</p>
On the Move	<p>Before travelling, tune into the local forecast and Met Office warnings. Visit www.metoffice.gov.uk and www.trafficwatchni.com</p> <p>Check the road conditions and think about alternative routes and allow extra time for your journey.</p> <p>Fully charge your mobile phone and take a charger with you.</p> <p>Make sure you have appropriate clothing, equipment and food.</p> <p>Pack an emergency travel kit – this will stand you in good stead at any time of the year.</p> <p>If your area is at risk of flooding, remember you should not drive or walk through flood water. Six inches/15cm of fast-flowing water can knock over an adult and two feet/just over ½ m can move a car.</p>
In your Community	<p>Helping each other a little can make a big difference.</p> <p>Identify family members or neighbours who may need an extra helping hand if severe weather strikes.</p> <p>Have their phone numbers to hand.</p> <p>Offer help with grocery shopping or other essential tasks.</p> <p>Clear ice or snow from their pathways.</p> <p>If you are part of a community group, think about what your group can do to help others during bad weather.</p> <p>Remember Northern Ireland Electricity Networks (NIE Networks) offer a critical care information service to customers who are dependent on life supporting electrical equipment. Customers on this register will receive up-to-date information by phone during a power cut or a planned interruption. Please call 03457 643 643 to register.</p> <p>Mains Water Supply</p> <p>Northern Ireland Water offers a range of additional services to older customers or customers who have serious medical conditions or need extra help for any other reason. Keeping Adults Safe: Training for Managers, Supervisors and Management Committee Members

This is a FREE 1 day certificated course - It is being held in Training Room 2, Downshire Hospital, Ardglass Road, Downpatrick BT30 6RA.*

This training will raise awareness of risk of harm in adulthood, provide a background into legal responsibilities in relation to adults at risk and examine the procedures that need to be in place for the recruitment, selection and management of staff and volunteers. It will assist voluntary, community and independent sector organisations working with adults at risk to achieve the minimum standards of best practice as outlined in the publication 'Keeping Adults Safe - A Shared Responsibility'.

- awareness of abuse issues;
- legal and policy context
- procedures for reporting concerns;
- code of behaviour for staff and volunteers;

BBC Children in Need Small Grants

- Behavioural or psychological difficulties
- Living in poverty or situations of deprivation



Projects we fund make differences in children's lives that help prevent or overcome the effects of the disadvantages they face. Projects achieve these differences by either working directly with children or seeking to improve their social and physical environments.

Cregganconroe: Community Benefit Fund

This local community fund has been set up by Gaelectric. A wind energy and energy storage company that believes in a sustainable future. Gaelectric is committed to ensuring that their wind farms, whilst having obvious environmental benefits, also provide significant economic benefits to the local community.

The Cregganconroe Community Benefit Fund (set up by Gaelectric) will be administered by the Community Foundation for Northern Ireland and will provide a fund available for local projects that educate, raise awareness and demonstrate community involvement in work that promotes environmental issues and healthier lifestyles.

Small grants ranging from £1000 to £2000 will be available to local community projects within a 10km/6 mile radius of the wind farm.
